This conference call will focus on 3 items very important to DESD.

### 1. Staffing of the DESD Officer positions. (Dustin Miller)

DESD Officers and Executive Committee members need to decide in this conference call the action the division will take to fill all DESD Officer and Executive Committee positions with members actively engaged in performing the functions of the position.

Dustin started the discussion by reviewing the DESD Officer staffing and proposed change officer assignments. Note that this was initially discussed during the December 20, 2017 DESD Conference Call. See the DESD December 20, 2017 Conference Call Minutes for discussion details.

We also discussed the duration for DESD Officers and Executive Committee members serving in each position, and the number of Executive Committee members. Leah noted that Rule 7 of the DESD Bylaws states that individual serves for one year, or possibly longer if necessary, and then moves up to the next position. Executive Committee members can serve for up to 4 years, and the Executive Committee shall consist of not less than 6 members.

The 2018 DESD Officer assignments, and Executive Committee assignment for Holly Wohlberg, are effective to the 2019 ANS Annual Meeting in June 2019.

Mark Campagna made the motion for the DESD Officers and Executive Committee members to accept the DESD staffing changes. Leah Spradley Parks seconded the motion. The motion was unanimously passed.

The following actions items need to be taken to finalize the DESD Officers and Executive Committee assignments.

- 1. Finalize Scott Zinkham as the Treasurer
- 2. Discuss and get agreement from Gerry Van Noordennen to fill both the Treasurer and Secretary positions until the new Treasurer is in position.
- 3. Identify and install the next Program Chair.

Doug Davis contact ANS Headquarters to discuss these staffing changes and provide Valerie Vasilievas with a copy of these meeting minutes.

#### 2. Staffing of the DESD Executive Committee positions. (Mark Campagna)

Holly Wohlberg will fill the open 2017 -2018 Executive Committee position and will continue as an Executive Committee Member through the 2018-2019 period.

Mark discussed the actions he has taken to submit the next DESD Executive Committee and Officer slate to ANS Headquarters. The slate was submitted and the DESD members recommended to staff these positions will be on this spring's ANS voting ballot.

### 3. ANS and Discovery Education (Holly Wohlberg discussion lead)

On January 15, we formally kicked off a partnership between ANS and Discovery Education to create a national curriculum and curricular materials for middle schools on nuclear science with a focus on nuclear energy. Discovery Education has curricula and curricular materials in about half of all schools in the U.S. We plan to introduce our curriculum and curricular materials for the 2018/2019 school year. Attending the kick off meeting for ANS were President Bob Coward, Executive Director Bob Fine, Education and Community Outreach Specialist Janice Lindegard and myself.

The purpose of this email is to request that you select <u>a person</u> from your Division that I can contact for technical review of the content generated by Discovery Education. Since President Coward has named me the point person to coordinate our validation of the technical content for

this project, I want to ensure this effort effectively leverages the expertise of all the ANS Divisions.

Your Division representative, if called upon, will review and provide feedback on the content that Discovery Education produces. Since the goal is to get this material into classrooms for 2018/2019 school year, the project needs to be completed by the end of July to be included in Discovery Education's digital textbooks. I don't foresee this taking more than 10 hours of your representative's time if he or she is called upon for assistance.
