PROGRAMS

The DD&R Division had a very successful ANS summer meeting in Atlanta in June. We organized 4 sessions at the meeting and these sessions are listed below. Thanks to Nadia Glucksberg and all our presenters for making these sessions a huge success.

Session Title: Groundwater Protection

The groundwater protection initiatives that are currently being completed highlight the potential for tritium (as well as other contaminants) to enter into the aquifers below active facilities. This not only impacts water quality, but the extent of impacted groundwater could trigger groundwater remediation and/or could impact decommissioning costs. This panel discussed case studies, the development of conceptual site models, and how this initiative has impacted individual plants.

Session Title: The U.S Army Corps of Engineers/FUSRAP: D&D of Non-Reactor Sites

Substantial progress has been made in the decommissioning of sites that are implemented by the US Army Corps of Engineers. These include both FURSAP at DOE facilities and non-FUSRAP sites under Superfund and follow EPA's CERCLA process to reach closure. These projects are often associated with unique technical and regulatory challenges. This panel discussed on-going challenges and lessons learned from FUSRAP and commercial non-reactor projects completed under USACE oversight.

Session Title: The History of Manhattan Era and Early Nuclear Power Facilities: Capturing the Historical Record While Performing Needed D&D

Sixty-five years after the Manhattan Project began; many of the aging facilities constructed during early nuclear power development are being demolished. One of the challenges during demolition activities is to preserve the historical record of the significant facilities, and in some cases, actually preserve a portion the buildings. This session provided some examples of how these challenges, to preserve an important historical heritage during D&D, are being met.

With the current Stock market decline from Oct'08, the decommissioning funds for the nuclear utilities have suffered in a decline of equity. For some nuclear facility D&D funds, this may present an issue in that the D&D funds are underfunded and may have issues in correcting the funding level. In some cases this is similar to much of the housing and commercial real estate markets that are in a negative equity basis. 
DD&R MEMBERSHIP UPDATE


